# **Tips for Successful Procurement...**

The purpose of this section is to provide a general overview for successfully competing and conducting business with the NOLA Public Schools (NPS). All open bid and proposal opportunities are available in real-time on our website (<u>https://nolapublicschools.com/community/business-resources/solicitations</u>). NPS contracting and purchasing practices will comply with all applicable Board Policies, Federal Laws and Louisiana State Laws, as amended and set forth in Louisiana Revised Statute Title 38, and other statutes with specific references.

- The Purchasing Department is committed to providing customer support and improvements; by streamlining the procurement process, based upon "best practices", expanding online capabilities, enhancing communications and maintaining transparency in all transactions.
- Check **weekly** for open bids and proposals, and other communications online. Please read and follow Invitations to Bids, Requests for Proposals and Request for Qualifications instructions carefully.
- When submitting a bid/proposal, carefully read all instructions and provide only the information requested. Failure to submit all information requested in an Invitation to Bid and/or adding information not requested on a Bid Form, shall render a bid/proposal non-responsive and rejected.

### Note: The most common reason that bids or proposals are *rejected* result from:

- A lack of submitting required information or documentation requested in the Invitation to Bid or Instructions to Bidders;
- Adding information or exceptions to a bid that is not requested;
- Failure to acknowledge addendums;
- Failure to properly complete or submit required forms and/or required documents;
- Failure to adhere to the DBE Provisions; and,
- Not in "Good Standing" or "Inactive" with Louisiana Secretary of State's Office.





## Procurement Requirements...

Equipment, Materials & Supplies are obtained by competitive bid and awarded to the lowest responsive and responsible bidder. Movables include: materials, supplies, commodities, equipment, vehicles, software, communications devices and systems, unattached fixtures, and similar items.

## **Procurement Requirements...**

**Professional Services (< \$50,000):** Professional Services under \$50,000 maybe awarded without the requirement of a competitive bid/proposal (i.e., consultant services, personal services, cooperative agreements, professional services.) Cost for the full duration of the project/initiative must be considered when determining the total cost of a particular service. Purchases cannot be divided by departments or by a school if the effect is to evade the States' public bid law.

**Professional Services (> \$50,000):** All purchases of consultant services exceeding the sum of \$50,000 to be paid out of public funds shall be advertised and let by purchase order or contract to the lowest responsible proposer who has submitted a proposal according to the specifications. A contract and Board approval is required for any professional service exceeding \$100,000.

**Construction and Public Works** are obtained by competitive bid and awarded to the lowest responsive and responsible bidder. Public Works is defined as the erection, construction, alteration, improvement, or repair of any public facility or immovable property owned, used, or leased by a public entity.



## **OPSB: DISADVANTAGED BUSINESS ENTERPRISE (DBE) PROGRAM**

The Disadvantaged Business Enterprise (DBE) Program is race & gender-neutral, and open to all business owners regardless of race, ethnicity or gender. DBE firms currently certified with the Louisiana Unified Certification Program (LAUCP), or the State & Local Disadvantaged Business Enterprise (SLDBE) Program must submit a copy of their DBE/SBE certification letter for eligibility with the offer/response to this solicitation.

When sourcing, Contractors/Consultants will use certified DBE Firms, as a first initial source. If selected, Contractors/Consultants will be required to report actual Disadvantaged Business Enterprise Sub-Contractor/Consultant(s); or Distributor(s) participation and the dollar amount, after award of contract for professional services. If at any time it's determined the Contractor/Consultant did not in fact utilize the DBEs submitted in the aforementioned DBE forms, to the extent initially indicated, the Contractor/Consultant shall be issued a notice of noncompliance, and will be expected to reach the levels of projected participation, as listed within the DBE Provisions.

Contractors/Consultants shall be required to report actual DBE participation, and the dollar amount of each professional hired.
A current DBE certification letter must remain valid for the duration of their contracted work.

- To ensure nondiscrimination
- To create a level playing field
- To ensure the DBE program is narrowly tailored
- To ensure only eligible firms are permitted to participate
- To help remove barriers to participation
- To promote the use of DBEs in all District-related procurements, purchase orders and contracts
- To assist the development of firms that can compete successfully in the marketplace

## **DBE PROGRAM SUMMARY ANALYSIS**

## (Advertised Projects)

- Since January 2018, the NOLA Public Schools Office of Business Partnerships has effectively managed and sustained ~33% DBE participation, on 31 construction related projects (publically advertised), valued at ~\$23M.
- In FY 2018, DBE Vendors secured 7 teaming agreements valued at \$2.2 million (~34%).
- In FY 2019, DBE Vendors secured 47 teaming agreements valued at \$10.7 million (~30%).
- In FY 2020, DBE Vendors secured 42 teaming agreements valued at \$6 million (~43%).
- Presently, in FY 2021, DBE Vendors has secured 18 teaming agreements valued at \$3,621,983 (~32%).
- DBE Vendors were individually awarded a total of 114 contracts: (<u>10</u> Prime contracts | <u>106</u> Subcontracts).
- DBE Vendors represented over 55 various construction trades.
- ~45% of DBE Vendors have participated on multiple construction projects.
