Acknowledge receipt of this addendum in the bid submission. This addendum is a part of the Contract Documents and shall be included in the Contract Documents. Changes made by the addenda take precedence over information published at an earlier date.

**This Addendum is issued in response to vendor inquiries and clarifications.**

1. Your response to question 9 in Addendum 2 did not answer my questions to clarify what I was asking in case it wasn't clear. Providing style numbers without listing the brand you gathered that style number from does not tell us which items you are looking for us to match. Can you provide the Brand/Manufacturer for each item listed so we know how to match it or find a comparable alternative?

**Response:** The referenced style number is provided for general reference only to indicate the desired style and quality and is not specific to a particular brand/manufacture. Proposers may submit products from any brand or manufacturer, provided the item is comparable in design, material, and overall quality. Please include sufficient specifications to demonstrate equivalency.

2. I want to clarify my question to question 7 on addendum 2. I understand if there may not be an existing contract for this bid; however, what I am asking is for the last contract that RTA used to purchase uniforms for operators including the items they were buying and the associated prices by the last awarded vendor. This is a request per FOIA (freedom of information act) that makes these previous awards public.

**Response:** RTA is unable to provide requested information.

3. You mentioned some tops get embroidery on select items. Which items on the bid will get the left chest RTA logo?

**Response:** Please Attachment A for logo image.

4. You mentioned new hire allotments in addendum 2 that included items not on the price sheet including two ties, two pairs of socks, and one belt. How would you like these items priced out? Additionally, will you only be ordering in the voucher system for new hires? If existing employees will also be ordering, how will that work if they aren't provided an allowance?

Response: All existing employees and new hires will order through the voucher system and be allotted an allowance. Please see Attachment B, an updated unit price form, with items referenced in Addendum 2. Please note that the new items do not have reference style numbers or images.
